



MomentFeed Order Form

This Order Form shall be governed by the terms of the Master Services Agreement (“Agreement”) dated November 1, 2017 between Color Me Mine (“Client”) and MomentFeed, Inc. (“MomentFeed”), which shall be incorporated herein by this reference. In cases of conflict between the Order Form and the Agreement, the Order Form shall prevail.

1. Service Purchased.

- a. **Term of Application Service.** The term of this Professional Service shall commence on August 16, 2018 unless earlier terminated pursuant to Section 2.b of the Agreement, and the Term shall be extended as set forth in subsequent Order Forms (each successive renewal term, a “Renewal Term”) (collectively “Term”).
